# **WELCOME TO SPRING!**

The daffodils are blooming, the birds are singing, the grass is growing, the lambs are gambolling, the days are getting longer, so welcome to spring! It is a great feeling especially after the awful year that we have had.



Temperatures are slowly rising. At this time of year, shorebird nesting season is almost upon us, and the birds are building up as much energy as possible to keep them fit and healthy during the summer. Some birds, such as sanderling and turnstone, migrate as far north as the high Arctic to nest but, some such as ringed plover, stay to nest on our beaches.

We also welcome back terns to the county at this time of year. Arctic and little terns nest on our shores in colonies, but ringed plovers are fiercely territorial, meaning their nests are well spread out along the coastline.

Please look out for areas that may be fenced off during the summer to provide these birds with a safe place to rear their chicks successfully. Follow us on social media (@spaceforshorebirds on Facebook and Instagram) for updates throughout the season.

Please keep your dog under control at all times to protect our shorebirds.

# LONGHOUGHTON TO LESBURY GREENWAY

#### BEACH ROAD AND PARKING ON THE DUNES

The Parish Council is aware that many residents and visitors are concerned about access to the beach via Low Steads Farm. Many comments have been made on Facebook and other media. Here is the up to date position.

There have been a number of meetings to look at the various issues around the amount, size and speed of traffic along Beach Road and the impact of greatly increased parking on the dunes and headland at Howdiemont and Sugar Sands. The Parish Council has reported back on these over the past few months.

This is a complex situation with the protection of the environment, the future of this coastal area which is part of the Area of Outstanding Natural Beauty (AONB), the sustainability of the farm at Low Steads, and the rights and responsibilities of the various partners which are all critical elements. The Parish Council has been working closely with many partners, including the owners of the farm, Howick Estates (who own the headland and dunes – there is no public right to park there; it is only by the agreement of the farm owners and Howick Estate), the National Trust (who have covenants on the land) and Northumberland County Council as the Highways Authority and others, to seek a solution to what is an unsustainable situation.

Last year, at its peak, up to 390 vehicles a day went up and down the road and parked at the beach; as a result, amongst other repercussions, there were accidents and "near misses" on the road and increased damage to the AONB. There have been a number of posts on the Parish Council's Facebook page about seeking to keep some parking access for local residents and disabled people and encouraging cyclists, walkers and runners as well as accommodating dogwalkers, buggy-pushers and other legitimate users of the route. Rest assured, the aspirations of the local residents is one of the issues uppermost in the minds of the farm, the landowners, the Parish Council and others.

No details of a management scheme have been finalised yet, and when they are drafted, there will be a community consultation about them. All partners want to be as open and as inclusive as possible. What is also agreed, however, is that the current situation, which will probably be as intense, if not more so, in this and future years, is not sustainable for many reasons. Please watch this space for future developments.

# **BEACH AND PARISH CLEAN-UP AND GRAFFITI**

The winter storms have deposited a whole range of materials on our beaches which are threatening the lives of species that live in the sea, birds and other animals. All sorts of plastic sheeting and other materials are still coming in and getting caught up in seaweed. Many people have been helping to clear this up and get it off the beach. On the weekend of 20/21 March the northern end of Seaton Point beach was an appalling mess. It has been suggested that we create an informal Beach Cleaning Group who could be called together on occasions when there is bad pollution. # **ULTRAFAST BROADBAND**

The Parish Council has been working with Councillor Wendy Pattison and iNorthumberland to bring ultrafast broadband to isolated properties in the very rural part of the Parish. Residents and businesses in the Denwick Lane End and some properties in Rennington Parish were recently asked if they wished to have an ultra-fast supply installed at their properties. Grants of up to £3,000 can be claimed to cover the costs of installation. Regrettably not enough residents applied to take advantage of this offer and the opportunity has been lost.

#### IMPROVEMENTS TO SCHOOL GREEN

Following consideration of a report that showed the village sculpture and its base to be deteriorating and in need of renovation, the Parish Council has given approval for a quotation to be obtained for considerable renovations. Also, the dilapidated seat will be replaced by a new five person bench.

#### A BRIDGE OVER HOWICK BURN

The bridge that used to cross the Howick Burn near the burn mouth was removed several years ago due to vandalism. It was put in over 25 years ago by the Percy Hunt. The Parish Council has been trying to get a replacement since the tree trunk over the burn was also removed on health and safety grounds by Howick Estates (on whose land the bridge would sit). This has been a lengthy process, not least because of Covid-19 and the difficulty in organising site visits by potential contractors. However, we now have a couple of



quotes for the work. Both are higher than we first anticipated for a number of understandable and legitimate reasons, but most importantly, the health and safety implications of building such a large-span bridge have increased over the past 20 plus years. As a result, the Parish Council has to look to see how it can afford to put in the bridge.

The route is a permissive one (not a Public Right of Way; access is only by the permission of the landowners, in this case the Low Steads farm and Howick Estates) so there are no obvious sources of funding. We have applied for grants, but have not been successful. We have also been donated some of the materials, but not all of them. However, we do need to look at it further to see how we can get the bridge in place. It is a valued route for the community and we are keen to do all we can to make it happen. As ever, though, such things are never simple, particularly if there is a limited amount of money available to implement the scheme. (If anyone has experience of crowdfunding, please make yourself know to the Parish Council!) In the meantime, many thanks go to the local contractors who have shown an interest in this scheme, despite the logistical difficulties of the site and the location.

# REMEMBRANCE DAY POPPY CASCADE: LONGHOUGHTON CARES PROJECT

Calling all knitters and crocheters! The aim is to knit and crochet poppies which will cascade over the sculpture on School Green, across from the church, in memory of the fallen. Hopefully we will have enough poppies to decorate the church gates and inside the church too. Animals who gave their lives will not be forgotten, symbolised by a purple poppy.
