LONGHOUGHTON PARISH **COUNCIL SIGNS THE** ARMED FORCES COVENANT

It was reported earlier in the year that Longhoughton Parish Council had agreed to sign the Armed Forces Covenant in view of the presence in the parish of RAF personnel and of course RAF Boulmer, the major employer in the parish. The signing ceremony took place at RAF Boulmer on 4th August 2022 when the Covenant was signed on behalf of the Ministry of Defence by the then RAF Boulmer Station Commander, Group Captain David Keighley, and on behalf of the Longhoughton Parish Council by the chair, Adrian Hinchcliffe. Following the signing Group Captain David Keighley said: "I was privileged to be able to jointly sign the Armed Forces Covenant with Longhoughton Parish Council. It is a great step forward in ensuring respect, support and fair treatment for all Service Families within our local community". Councillor Adrian Hinchcliffe said "On behalf of Longhoughton Parish Council I would like to say that the whole purpose of signing the

Covenant is to demonstrate the Parish's commitment to the Armed Forces and to bring the military and civilian communities together".

This summer has been challenging for coastal wildlife, but we are delighted to say that shorebirds have had a successful nesting season on the Northumberland Coast! Thirteen ringed plover chicks fledged from our nest protection sites, a fantastic achievement and huge improvement from last year. Big thanks go to the Coast Care volunteers who dedicated their time to help us throughout the season, and to local residents and visitors who gave space to the protected sites.

TRAFFIC VOLUMES THROUGH LOW STEAD FARM TO LONGHOUGHTON BEACHES

Traffic monitoring took place on the beach road at Lowsteads Farm from 18 July to 30 of August this year. During this period 4,782 vehicles went down the road to the beach during this 44 day period. The daily numbers were: lowest 31, the average 109 and the largest 236. Of the 4,782, 778 were campervans. During the same period the total takings of the £1 voluntary fee was £2,796 which means that the box is only taking 58% of what it should.

GREENWAYS AROUND LONGHOUGHTON

The Parish Council is gradually making progress with proposals for greenways around the village of Longhoughton. These are safe routes off the main road away from motorised traffic for walkers and cyclists. They are safer for children away from the traffic. In an earlier consultation they were termed 'the green necklace'. It is anticipated that funding for some of the greenways

will come from the AONB Coastlands Project. Once the potential routes are identified there will be a full consultation.

THE ENERGY AND THE CLIMATE CHANGE CRISES

The energy crisis fuelled by the Ukraine war is going to badly affect all households, especially those who depend on oil for heating for which there is no price cap. The Parish Council is also very concerned that those individuals or families with low incomes may be facing a very difficult time. Do not hesitate to contact any Parish Councillor about your situation and we will signpost you to the agencies that may be able to help.

In addition, we are confronted with the increasing challenge of climate change. Many people have unanswered auestions, such as alternative heating systems to replace gas boilers. How good is your existing insulation and can it be improved? When should you change your car for an electric vehicle and where can it be charged? What system could you use to move off oil-heating. These are just a few examples of issues that people are beginning to think about. The Parish Council will be

When she complained to the operators that the Longhoughton bus had gone out before the Newcastle bus had arrived they commented 'the driver was unaware of the Newcastle bus coming into the bus station and the timetable does not state that this is a connection'. How ridiculous and this is a perfect example of poor connection and poor service.

WHAT'S ON AT THE COMMUNITY AND SPORTS CENTRE

The Trustees want to make all residents aware of the many activities that are going on at the Centre (Westfield Park) and so are distributing a special leaflet with this Newsletter. Sport England has given funding to help promote many of the activities at the Centre. There are many opportunities for you and all members of your family to get involved and many of them are free of charge. Our Trustees are keen to provide activities for all ages and all needs, so we hope that you can find something which is of interest to you. If not please let us know and we will see what we can do!

APPLICATION TO VARY THE PREMISES LICENCE

The Trustees of the Community and Sports Centre (Westfield Park) have applied to the Licensing Authority to vary the Premises Licence as follows:

- To amend the opening times from 9am to 8am Monday to Sunday
- To amend the licensed start time for events like plays, dancing, playing live or recorded music, playing of films or other streamed entertainment, from 10am to 8am Monday to Sunday.
- To amend the licensed hours for the sale and consumption of alcohol from 5pm to 11pm Monday to Friday and 12 noon to 11pm Saturday and Sunday, to 10am to 11pm Monday to Sunday.
- To amend the area that is licensed for the sale and consumption of alcohol to include some part of the centre grounds around the centre building.

An official notice of this application has been on the noticeboards since late July and all residential properties around the centre were given a copy of this proposal.

The changes in opening times are already approved legally so this is just to bring the licence in line with the law. The change in the times for the sale and consumption of alcohol has to be approved by the licensing authority. By the time you are reading this newsletter we should know whether this has been approved. The Trustees would like all residents to know that these changes are to make it easier for the centre to operate and of benefit to residents and organisations that hire the accommodation. Having the alcohol licence is an optional extra in hiring the accommodation which has to be approved by the Trustees. We

do not expect much change in the way that the alcohol licence has been used over the last few years but the widening of the licensed times gives more flexibility should some hirers wish to sell alcohol.

Where individuals bring their own alcohol or where it is given away free of charge, these circumstances are not affected by

the change.

RENEWABLE ENERGY PROJECT

The Community and Sports Centre (Westfield Park) has been part of a feasibility study along with 18 other similar buildings throughout



Northumberland for the installation of solar panels on the roof and battery storage. The prime objective would be to be self-sufficient in electricity use and an exemplar within the parish.

The centre has a perfect roof for generating solar energy. The roof is south-facing and is capable of taking 162 solar panels. The scheme was costed at £43,181.00 + VAT for sun panels and battery £25,676 + VAT for battery storage and a smart management system. The surplus electricity generated will be sold to the market along with the other participants.

The scheme is to be formerly announced shortly.

CREATION OF A NEW USABLE SPACE

All consents are now in, apart from planning permission, to turn two unused changing rooms into a usable space. This is the space that could be used for all types of activity including some clinics run by Alnwick Medical Group. We are on schedule to have this space fully in use by 31 March 2023.

THE ASTRO-TURF PITCH

The Astro-turf football pitch at the Community and Sports Centre (Westfield Park) is now thirteen years old and is worn out. The Football Association recently refused to re-certify the pitch due to its age and condition. The trustees are in talks with the Football Foundation about its replacement. The centre has saved a sinking fund of almost £67,000 from its hire over the years since 2009 but the quotation for the replacement is £137,424. The Football Foundation may help with some funding but we are likely to be short by around £66,000 to enable the pitch to be replaced. Funding is being sought from possible sources.

VOLUNTEERS SOUGHT

Volunteers are sought for opening and closing the Centre. It only takes five minutes and if we have enough volunteers each person would only be asked once each week. Please volunteer. Howick News PARISH COUNCIL SURGERY A HOWICK VIEW

The parish council surgery, held on 17 September at the village hall, was an opportunity for residents to meet Chris Thomas, their recently appointed councillor, and to share their views on whatever topics they felt strongly about. The new councillor introduced himself and explained that his public service to date included a background in education. In recent years he has been supporting Longhoughton Parish Council by designing and producing its communication needs, as a volunteer.

Chris says that he felt gratified to meet villagers and that the opportunity was useful to put forward a number of issues around the table.

The issues which surfaced at the surgery included the aftermath of Storm Arwen and our relationship with environment.

Storm Arwen left the group with three principle areas of concern in the event that the experience is repeated: Firstly, a means of communication without power in an area with poor mobile phone reception; secondly, to persuade Northern Power Grid to bury the power supply below ground in vulnerable places; thirdly, to publish and broadcast an emergency strategy designed to help



the community during power cuts in the future. The feeling in the room was that long power cuts were likely to reoccur, and that the same extreme problems experienced by residents would be intollerable. Regarding the environment, it was clear that residents held an unusually sensitive and well-informed view and that they wanted to promote best practice. It was clear that the natural environment in this neck of the woods is much appreciated and valued. We were all reminded that strateaies such as leaving grass uncut and discouraging the use of weed killers is helpful to the wildlife. It was noted that this very much echoes the longstanding approach of the trustees of Howick estate.

The parish council is always keen to listen to views expressed across the whole parish so that it can be guided by such evidence as it moves forward on behalf of its population.
